The Oswald Murder Trial

History shows that a murder trial for Lee Harvey Oswald was not possible because the “suspect” was murdered soon after the assassination of President Kennedy. However, the evidence that could have been brought to bear on such a trial does exist which can be used by anyone to make their own decision on the guilt or innocence of Lee Harvey Oswald. A portion of that evidence for the defense is listed below.

THE EVIDENCE FOR THE DEFENSE

- o Oswald adamantly denied any involvement in the murders of Kennedy or Tippit
- o Psychological stress test shows Oswald to be truthful in his responses; (“I’m a patsy!”)
- o Oswald was working as a CIA operative while in Dallas, Texas (i.e. secret government employee)
- o The “reported” assassination rifle cannot be linked to Oswald, only to an intelligence alias
- o Direct and overwhelming evidence that the CIA was responsible for the Kennedy murder
- o A fake Oswald in Mexico points directly to frame-up of Oswald by elements of the U.S. Gov.
- o Cover-up of medical evidence points to a frame-up of Oswald by elements of the U.S. Gov.
- o Original medical evidence proves that at least two riflemen were shooting at the President
- o Best FBI marksman could not duplicate the reported three rifle shots.
- o Bolt on the “reported” assassination weapon stuck, and was difficult to operate
- o The “reported” assassination weapon was poorly sighted and inaccurate
- o Oswald’s proven poor marksmanship with a rifle precludes his firing with accuracy
- o So-called “Magic Bullet” did not match any rifle and had no biological material present
- o Dozens of witnesses were murdered to uphold the U.S. Government cover-up
- o Oswald could not have known when the motorcade would drive past the TSBD
- o No one saw Oswald bring any weapon into the Texas School Book Depository
- o Witnesses reported that Oswald did not bring anything into the TSBD on Nov. 22, 1963
- o No one saw Oswald fire a weapon at the motorcade
- o No witness can place Oswald on the 6th floor during the assassination
- o Witnesses place Oswald on the 1st and 2nd floors just before and after the assassination
- o No Oswald finger prints found anywhere around the so-called “sniper’s nest”
- o No Oswald finger prints found on the so-called assassination rifle
- o No evidence that Oswald fired a rifle on November 22, 1963
- o Faked backyard photos of “Oswald” with a rifle points directly to a frame-up of Oswald
- o Three rifles were located at the TSBD; none directly linked to Lee Harvey Oswald
- o Government doctored photographic evidence of the assassination shows cover-up
- o Government doctored medical evidence of the assassination shows cover-up
- o Missing photographic evidence of the assassination shows cover-up
- o Continuing cover-up of assassination documents which would prove Oswald’s innocence
- o The alteration of the Dealey Plaza crime scene shows cover-up by the U.S. Government
- o Acoustical evidence clearly shows two gunman fired at the President
- o No fewer than 51 witnesses report shots fired from Grassy Knoll
- o Testimony of Governor Connally indicates two gunmen firing at motorcade
- o Oswald revolver was non-functional
- o Oswald revolver was not matched to the bullets or Tippit murder
- o Witnesses testified that two men were involved in Tippit murder
- o Oswald cannot be placed at the Tippit murder scene
- o Finally: Lee Harvey Oswald was murdered to prevent him testifying in open court

“TRIAL TESTIMONY”
BY THE HOUSE OF REPRESENTATIVES SELECT COMMITTEE ON ASSASSINATIONS

1. The HSCA completed its investigation in 1978 and issued its final report the following year, concluding that Kennedy was probably assassinated as a result of a conspiracy.

2. Scientific acoustical evidence establishes a high probability that at least two gunmen fired at the President. The committee was unable to identify the other gunmen or the extent of the conspiracy.

3. Other scientific evidence does not preclude the possibility of two gunmen firing at the President. Scientific evidence negates some specific conspiracy allegations. The committee believes, on the basis of the evidence available to it, that Kennedy was probably assassinated as a result of a conspiracy.

4. The Committee further concluded that it was probable that four shots were fired; the fourth shot came from a second assassin located on the Grassy Knoll.

5. The Department of Justice, FBI, and CIA, were all criticized for not revealing to the Warren Commission information available in 1964 and the Secret Service was deemed deficient in their protection of the President.

6. The HSCA made several accusations of deficiency against the FBI and CIA. The accusations encompassed organizational failures, miscommunication, and a desire to keep certain parts of their operations secret. Furthermore, the Warren Commission expected these agencies to be forthcoming with any information that would aid their investigation. But the FBI and CIA only saw it as their duty to respond to specific requests for information from the commission. However, the HSCA found the FBI and CIA were deficient in performing even that limited role.

7. Newly declassified documents show that CIA director, John A. McCone, hid evidence from the Warren commission, set up by Lyndon Johnson reportedly to investigate JFK's assassination. According to a once-secret report written in 2013 by the CIA's top in-house historian, David Robarge, the CIA admits McCone and other senior CIA officials withheld 'incendiary' information from the Warren Commission thereby perverting the course of justice.

During a later interview Dallas Police Chief Jesse Curry made a statement about whether or not he had any evidence that Oswald had killed President Kennedy. **“We don't have any proof that Oswald fired the rifle, and never did. Nobody's yet been able to put him in that building with a gun in his hand.”**

THE VERDICTS

During 1992 the American Bar Association held two mock Oswald trials. The first trial ended in a hung jury; the second jury acquitted Oswald of Kennedy's murder!

If Oswald was the Lone Assassin...

If Lee Harvey Oswald was the lone assassin of President John F. Kennedy then there are questions which must be answered by those who believe that official storyline, if only for themselves. Most if not all of these questions would have been asked at a public trial if Oswald had not been murdered soon after the murder of the president.

After covering up the facts of the Kennedy assassination for more than a half a century it is no longer acceptable for the United States government to simply state that Lee Harvey Oswald was the lone assassin – they must prove to the American people that not only was there no conspiracy, but PROVE in a court of law that he committed the murder alone! It is not up to individuals to prove that Oswald did not shoot President Kennedy. It is now up to the government and their supporters to PROVE that Oswald committed this murder.

If this was truly a simple case of one man murdering another there would be no evidence of any conspiracy. Therefore, if the following questions cannot be satisfactorily answered, PROVING he acted alone, then these questions as a group stand as proof that Oswald was not a lone assassin and was framed by a small group of men working inside the United States government, who were responsible for both the murder of the president, Oswald and several others as part of a coup d'état, and a post assassination cover-up.

If these questions can be satisfactorily answered, PROVING there was no conspiracy; then Oswald acted alone. Again, is not good enough to simply state that Oswald was the lone assassin it must be proven in a court of law that he, and only he, was responsible for the death of President Kennedy. Hard, direct questions must be asked and answered by those in power.

Therefore, if Oswald was the lone assassin...

CIA

- o Why was there a constant set of CIA operatives around Oswald as he worked on CIA projects both in and outside of military service right up until the murder of President Kennedy?

- o Why was Oswald's contact from the United States Embassy in the Soviet Union a CIA agent named Captain Dr. Alexi Davidson?

- o Why did French gunman Jean Souetre come to Washington, D.C. to meet with CIA Counter Intelligence Chief James Angleton in early November 1963?

- o Why was there a CIA section chief named J. Walton Moore assigned to Dallas, Texas in 1963?

- o Why did CIA agent David Phillips meet Oswald in Dallas in September of 1963?

- o Why did CIA agent David Phillips with a death bed confession admit being "operational" in Dealey Plaza on November 22, 1963?

- o Why did CIA agent David Morales brag about rouge agents in the CIA killing both Kennedys?

o Why was the windshield on Kennedy's limousine with the bullet hole in it removed from the vehicle and destroyed by George Whitaker, manager of the Ford Motor Company Rouge Plant in Detroit, under secret service instructions only three days after the assassination?

o Why did Dr. James J. Humes destroy his Kennedy autopsy notes?

o Why was Kennedy's wounds altered on his body to cover-up the real medical evidence?

o Why was the Dealey Plaza murder site altered (signs, trees, roadway) to make reconstruction of the assassination impossible?

o Why does the Zapruder film show Kennedy's head slammed back and to the left after he was shot in the head from the front-right ?

o Why if Marina Oswald took the backyard photos of Oswald did she state that she "never knew her husband owned a rifle, nor a pistol"?

JEAN SOUETRE

o Why was French military sniper Jean Souetre arrested in Fort Worth, Texas after having been in Dallas on November 22, 1963 and then allowed to leave the United States?

o Why did the CIA produce a document, which was released in 1977 during the House Select Committee on Assassinations, proving that CIA contract sniper Jean Souetre was in fact in Dallas, Texas on November 22, 1963?

FAKE MEDICAL EVIDENCE

- o Why did seven eyewitnesses report gun smoke rising off the Grassy Knoll behind the fence?
- o Why did one witness smell gunpowder coming from the Grassy Knoll just after the assassination?
- o Why was there a man with false secret service credentials in the police parking lot behind the Grassy Knoll after the shots?
- o Why did Jean Hill who was one of the closest witnesses to the assassination and reported she saw the gunman fire the rifle from behind the fence at the Grassy Knoll receive several death threats?
- o Why did eyewitness Ed Hoffman who was west of the Grassy Knoll see a man take the gun apart and hand it to a second individual?

WARREN COMMISSION

- o Why did the Warren Commission fail to call the witness, Mrs. Reid who saw Oswald on the first floor "moments after the gunfire"?
- o Why did Gerald Ford on the Warren Commission OK a change on the back wound medical drawing to show a higher entry wound?
- o Why did the members of the Warren Commission lie to the American people and report that Oswald was the lone assassin?

CBS 'NEWS'

- o Why did CBS 'news' man Dan Rather lie about the direction of President Kennedy's head after he was shot in the head?

JACK RUBY

- o Why was Jack Ruby at Dealey Plaza before, during, and after the assassination?
- o Why was Jack Ruby at Parkland Hospital after the assassination?

- o Why did Jack Ruby meet with mafia hit man Johnny Roselli twice in Miami in October 1963?

- o Why was Mary Pinchot Meyer, whose husband worked for the CIA, murdered after she publicly denounced the Warren Report, stating that “it was a whitewash” and a CIA cover-up?
- o Why was Manuel Rodriguez Quesada, who had inside information on the assassination team murdered before he could testify?
- o Why was Maurice Gatlin, a key witness to Kennedy conspiracy, which included Guy Banister in New Orleans, murdered before he could testify at Clay Shaw’s trial?
- o Why was Melba Christine Marcades, who reported to police in Louisiana on November 20, 1963 that a plot was made to kill Kennedy in Dallas in two days murdered?

- o Why was Lee Bowers, Jr., who saw the sniper and the spotter behind the fence at the Grassy Knoll murdered?

- o Why was Marilyn Welle, a dancer at Jack Ruby's club who reported seeing Oswald with Ruby at the club murdered?
- o Why was David Ferrie murdered days before he could testify at Clay Shaw's trial in New Orleans about the Kennedy assassination?
- o Why was Eladio del Valle murdered on the same day as David Ferrie days before he could testify at Clay Shaw's trial in New Orleans about the Kennedy assassination?
- o Why was Robert F. Kennedy murdered days after he informed associates that if elected he would "reopen the investigation into Jack's murder"?
- o Why was Rolando Masferrer, who worked with 'plumbers' Hunt, Sturgis and Barker on Watergate and named as one of the men who participated in pre-assassination planning murdered?
- o Why was CIA agent George de Mohrenschildt, Oswald's CIA watchdog, murdered three hours before he was scheduled to testify at the House Select Committee on Assassinations?
- o Why were five FBI agents including Louis Nichols, Alan Belmont, James Cadigan, Donald Kaylor, J. M. English, and FBI Director of Domestic Intelligence William Sullivan, all killed during a six month period in 1977 before they could testify at the House Select Committee on Assassinations?
- o Why was Soviet KGB double agent John Paisley murdered after he informed friends that he had "knowledge of the true nature of the Kennedy assassination"?

AND FINALLY

o **Why**, if Oswald was the lone assassin, was it necessary to murder him before he could testify at his trial?

Answer: The small group of men inside the government of the United States, who murdered President Kennedy, and several others, did not need a live defendant; they needed a dead patsy, and his name was Lee Harvey Oswald!
